Executive Summary:

Council has again received a large number of tender submissions for the Plant Hire Tender for the 2014 Construction Season which closed on 4 April 2014.

Assessments have been completed by the assessment panel and placed in the preferred supplier order for each tender. Schedules for each of the tenders have been prepared for Council's consideration and approval.

4.2 DRY HIRE OF FIFTEEN (15) MIXED ROLLERS TENDER 14/0364

Executive Summary:

Tenders for the dry hire of construction rollers closed on 28 March 2014 with five tenders submitting seven tender options. The tenders have been assessed for value for money to Council and the local community. All submissions were conforming, of high quality and of similar specification, with out any consequential departures to the specification being found. It is recommended that Council accept the Tutt Bryant Hire option to supply new rollers for the contract period of twenty-four months.
