Executive Summary:

Council received a late tender for the ROPS Wet Hired Plant 2024 (Contract No: 24-0001). In & Out Mechanical has a semi water cart available for immediate start and would like Council to consider their late tender for this plant.

RECOMMENDATION:

That Council approve the late tender.

Background:

Council has exhausted the current local and non-local prequalified suppliers list and are in desperate need for more water trucks. Council has gone through Local Buy for the North Queensland Region and have been unable to engage a suitable supplier as they are fully engaged.

A request for tenders for the ROPS Wet Hired Plant 2024 (Contract No: 24-0001) was issued by Carpentaria Shire Council on 6 October 2023 and closed on 17 November 2023. Sixty-eight (68) suppliers submitted tenders.

Ten (10) items of plant were requested within the ROPS Wet Hired Plant:

- D2.1 Grader
- D2. Scraper
- D2.3 Bulldozer
- D2.4 Front End Loader
- D2.5 Excavator
- D2.6 Crane
- D2.7 Water Truck
- D2.8 Side Tippers
- D2.9 Low Loader (Float)
- D2.10 Miscellaneous

The successful tenders were determined in the December 2023 Council Meeting.
